### **RE-REVISED**

The Quincy-Columbia Basin Irrigation District will start filling the West Canal *later than previously revised* due to continued unforeseen winter weather conditions; The **RE-REVISED** date being scheduled is **Saturday 9:00 P.M, March 23, 2019**. Priming will continue on smaller canals and laterals through the first week in April, depending on the weather and the demand for water deliveries.

Telephone recorders will still be available on March 25<sup>th</sup> in all watermaster offices for water ordering. This service will be available on Saturdays and up to 11:30 A.M. on Sundays for the following Monday's water order, throughout the season.
